Who can enter?	Only Australian residents who are aged 18 or over.
Who can't enter?	Directors, officers, management and employees (and their immediate families) of: (a) the Promoter; and (b) the agencies, companies or participating premises associated with this competition.
Where will the competition run?	The competition will run online on the Website only.

Entry instructions	You must during the Competition Period: (a) visit the Website and follow the prompts to locate the Dry Quiz page; (b) answer all of the questions presented in the Dry Quiz; and (c) fill out and submit the online entry form including by signing up to the Carlton Dry database and providing all other requested information, to enter the draw. The Promoter is not responsible if your mobile device/desktop is not sufficiently capable for the purpose of submitting an entry.
How many winners will there be and how will they be chosen?	There will be 1 winner determined in respect of this Competition.
